## What does "DaSy" stand for?

DaSy is short for data systems—specifically, the Center for IDEA Early Childhood Data Systems. IDEA is the Individuals with Disabilities Education Act. There are two early childhood programs in IDEA: early intervention (Part C of IDEA), which is for children ages birth through 2 with delays and disabilities and their families, and preschool special education (Section 619 of Part B of IDEA), which is for children ages 3 through 5 with delays and disabilities. DaSy refers to the data systems for both these programs.

#### What is the main purpose of DaSy?

The main purpose of DaSy is to provide state Part C and Part B preschool programs with technical assistance in developing and enhancing integrated early childhood data systems to improve state capacity to collect, analyze, and report high-quality IDEA data.

# Why is it important for states to develop and enhance integrated early childhood data systems?

Data systems are tools to improve programs and, ultimately, outcomes for children and families. Young children with disabilities are served in early intervention and preschool special education programs, but they also may be served in other early childhood programs in their communities such as Early Head Start, Head Start, child care, and state prekindergarten. Having integrated early childhood data systems enables states to link data across these programs. These linkages provide powerful information about who programs are serving, what services they are receiving, and who is providing those services. Policymakers, state agency staff, local program staff, and others need high-quality integrated early childhood data systems to improve early intervention and preschool special education services and supports to better serve children and families and to answer important program and policy questions.

# Who funds DaSy?

The DaSy Center is funded by the U.S. Department of Education's Office of Special Education Programs (OSEP).

# How long is DaSy being funded?

DaSy is being funded for five years, from December 1, 2012, through November 30, 2017.

## Technical Assistance (TA)

## What kinds of TA does DaSy provide?

The DaSy Center provides a continuum of TA for Part C and Part B preschool state staff and other state staff. TA activities include convening national meetings, conducting topical meetings or think tanks, forming and supporting communities of practice, holding national webinars, and developing online, print, and video training materials. Although our TA is targeted for Part C and 619 state agencies, many of the activities such as conferences and webinars are open to anyone who is interested. In addition to general TA for all states and territories, DaSy will provide individualized TA as requested.

In years 2 through 5, the DaSy Center will provide 10 states with intensive TA. DaSy staff and stakeholders in these states will develop and implement a TA work plan based on priorities identified by the Part C and Part B preschool programs.

#### Who can request state DaSy Center TA?

State personnel working with Part C and Part B 619 programs are encouraged to request TA. Other individuals and TA centers also can contact DaSy on behalf of their state clients with questions related to our scope of work. # If my state requests TA, will DaSy require that we make specific changes to our state data system?

No. The DaSy Center provides TA to states based on state-identified needs and questions. Our goal is to help each state make good decisions about its data systems, but decisions always are made by the state.

# Does DaSy have recommendations about what state data systems should look like?

In the first year of our project, DaSy is working closely with seven states to develop a framework that identifies the key components and quality indicators of an effective data system for Part C and 619 and the integration of those data with other state systems. The seven states are Alaska, Arkansas, Connecticut, Georgia, Idaho, Massachusetts, and Pennsylvania. The framework will:

- Provide a structure for DaSy's TA
- \* Be a tool states can use as a self-assessment of their data systems including identifying areas for improvement
- Identify strategies for coordinating data systems to connect data about children across programs and over time.
